CLASS A MEMBERSHIP

Class A Members enjoy unlimited golf with no green fees, use of the practice facilities, unlimited use of the swimming pool and clubhouse and access to all events and activities at Panama Country Club. Membership privileges extend to the Class A member's dependents as well. Class A Members must purchase a share of stock that entitles the member to vote and hold office at the Club. Class A members can also use their own carts, with the payment of monthly trail fees. Class A members may invite one accompanied guest to play for free with use of private cart. Four guests may accompany Class A members each day of normal pool hours for free. Class A members enjoy reduced Tournament fees as designated by General Manager.

GENERAL MEMBERSHIP INFORMATION

- Each membership must spend a minimum of \$25.00, not including tax or gratuities, per month on prepared foods from the clubhouse. Non-resident Members are responsible for \$25.00 food minimum per quarter. Annual Retired Members are responsible for \$12.50 per month. The food minimum extends to each designee of a corporate membership.
- Each membership (except Non-resident) is billed up to a \$15.00 per month fee for the Capital Improvement Fund. The Capital Improvement Fund will be charged to each corporate designee.
- All applications must be accompanied by a check for the first month's dues, capital improvement fund, and stock certificate, if applicable.
- All membership accounts will require a credit card on file to handle all charges accrued within the month and for payment on monthly dues.
- All fees and charges are subject to applicable Florida State Sales Tax.
- The Board of Directors must review and approve all applications for membership.
- All members are billed a \$25 employee Christmas contribution in September of each year. Members who request not to contribute will be issued a credit back to their member account the following monthly statement.
